

ORDINANCE NUMBER 25.

AN ORDINANCE CONCERNING LISENCES FOR THEATRES,
PICTURE SHOWS, CIRCUSES AND OTHER PUBLIC INTER-
TAINMENTS.

Be it ordained by the Board of Trustees of the Town
of Arriba, Colorado;-

Section 1. That it shall be unlawful for any person,
firm or corporation to conduct, operate or maintain any
theatre, motion picture show, vaudeville show, circus,
street show or other exhibition, show, or entertainment,
within the Town of Arriba, for gain or profit, without
having first obtained a license as herein provided, ex-
cept that for dramatic or musical entertainments, and
all exhibitions given or made by citizens of this town,
no license shall be required.

Section 2. . The Mayor is hereby authorized in his
discretion to order the issuing a license to any person,
firm, or corporation to conduct, operate or maintain any
of the entertainments mentioned in the preceding section
upon payment of the fees provided in this ordinance.


Section 3. The license fee to be charged for such
exhibitions or performances shall be as follows;-

(a) For picture shows, the sum of \$5.00 per month, or
for a shorter period the sum of \$2.00 per day or part
thereof, and no license for any picture show shall be
issued for a longer period than six months.

(b) For circuses, the sum of \$10.00 for each day or
part thereof.

(c) For exhibitions or performances of all shows or
entertainments not hereinabove provided for, such fee
as shall be fixed by the mayor.

Section 4. All licenses issued under this ordinance
shall be signed by the Town Clerk pursuant to the order
of the Mayor, and upon the payment of the sum assessed
therefor.



Section 5. All licenses issued under the provisions of the ordinance shall specify the object and length of time for which the same shall be granted.

Section 6. Any license issued under the provisions of this ordinance may be revoked in the discretion of the Board of Trustees if it shall appear that the Licensee has not complied with the ordinances and regulations of the Town of Arriba, or if the licensee shall have practiced fraud, misrepresentation or imposition.

Section 7. Any person or persons who shall vend, sell or retail any article of any kind whatsoever upon the streets, sidewalks or alleys within the Town of Arriba, where the sale of such article is advertised by, or accompanied by, any concert, music of one or more instruments, singing, pantomime, acrobatic or other performance, designed to attract attention, or who shall give any trapeze or other exhibition on or across any street, alley or sidewalk, whether the receipts therefrom are to be by voluntary contribution or otherwise, shall be considered as giving a street show, and shall secure a license therefor.

Section 8. Any person, firm or corporation violating any provision of the ordinance shall be fined not less than \$5.00 nor more than \$50.00 for each offense. Every day any such violation shall constitute a separate offense.
