## AN ORDINANCE CONCERNING OFFENSES.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF ARRIBA; COUNTY OF LINCOLN STATE OF COLORADO.

SECTION I. Any person who shall be drunk or shall be in a state of intixication in any public place within this town, or shall be drunk and disorderly in any private house or place, upon conviction thereof, shall be fined in asum not less than five dollars nor more than fifty dollars; and the town Marshal and all police officers of this city are hereby authorized and empowered, and it is hereby made their duty, to arrest, with or without process, any person found violating any provision of this section and commit such person to the jail or other safe place until sober, at which time or as soon thereafter as may be, such person shall be brought before the Police Magistrate to be dealt with according to law.

exhibit or perform any lewd, indecent or immoral play or representation, or shall exhibit, sell or give away any lewd, indecent or immoral book, picture or other thing, or shall deface or place upon any building or other thing any lewd or indecent picture or

writing, or shall in any public place use any lewd or indecent language, upon conviction thereof, shall be fined in a sum not exceeding one hundred dollars and costs.

SECTION 3. Any person who shall indecently expose for service any stallion. bull or other male animal in any public place in this town or in any place exposed to public view, upon conviction thereof, shall be fined in a sum not exceeding twenty-five dollars and costs.

SECTION 4. Any person who shall, within this town inhumanly, cruelly or unnecessarily beat, injure or otherwise abuse any dumb animal or fowl, or shall cause instigate or encourage any dog-fight or cock-fight, upon conviction thereof, shall be fined in a sum not exceeding fifty dollars and costs.

SECTION 5. Any person who shall set up, have or keep any keno table, faro bank, shuffle board, bagatelle, playing cards, dice or other instrument or device, or thing whereby, whereon or with which any money or other thing of value shall in any manner be played for; and any person who shall play for any money or thing of value at any game with cards, dice or with any article or device or thing whatsoever which may be used for the purpose of playing, or betting upon, or winning or losing money or other property; and any person who shall bet or wager upon any game others amy be playing, upon conviction thereof, shall be fined in a sum not less than ten dollars nor more than two hundred dollars and costs.

And any person who shall knowingly permit any building, room or tenement of any description by him owned or controlled, to be used for any of the purposes in this section mentioned, upon conviction thereof, shall be fined in a sum not exceeding fifty dollars and costs.

SECTION 6. Any person who shall, within this town cause, engage in, instigate or encourage any riot, rout, affray or fight; and any person who shall disturb others by loud and unusual noises, or by violent, timultuous, offensive conduct or carriage; or by unseedy, profane, obscene or offensive language calculated to provoke a breach of the peace; and any person who shall disturb any congregation or assembly met for religious worship by making a noise; or by rude or indecent behavior, or by profane or indecent language within their place of worship, or so near the same as to disturb the order and solemnity of the meeting; or shall in like manner disturb or interfere with any lawful assembly of people peaceably assembled, upon conviction thereof, shall be fined not exceed.

ing fifty dollars and costs.

SECTION 7. Any person, not in the employ of a railway company, who shall within this town jump on or off, or catch hold of any railway car or engine when the same is in motion; or shall ride upon the steps or trucks of any engine or car; or any person who shall interfere with the lawful pperation of any railroad or railroad train, or shall place any obstruction upon or in anywise interfere with any railroad track, upon conviction thereof, shall be fined not exceeding fifty dollars and costs.

SECTION 8. Any person who shall, within this town throw any stone or other missile at or upon any person, animal, building, structure, tree or shrub; or shall wilfully injure, defece, mark, mar or destroy any building, structure, fence, enclosure or other improvement or any tree shrub, plant or flower, planted for ornament or shade upon any public or private grounds, he not being the owner thereof; or shall cut, fill, obstruct or otherwise injure or damage any ditch, drain, sewer, water main or pipe, or any sidewalk, bridge or culvert; or shall obstruct or in any manner encumber any strees, ally or sidewalk; or shall erect any building in whole or in part upon any street, ally, sidewalk or public grounds within said town, without first having obtained written permission from the Board of Trustees, of having erected any such building or structure shall fail to remove the same within twenty-four hours, when notified so to do by the town marshal or mayor, upon conviction thereof, shall be fined in a sum not less than five dollars nor more than two humdred dollars and costs. Every day any such structure shall remain after notice to remove the same shall constitite a separate offense.

SECTION 9. No person or corporation shall, without the written permission of the Board of Trustees first had and obtained, make any excavation of any kind or character in any street, alley or public place, or remove from, or deposit upon, in any place any hay, straw, manure, boxes, barrels, building material or other matter, All excavations herein specified shall be safely guarded by a suitable rail or fence, and if left open at night shall be further provided with red lights, in order that persons and animals shall not fall therein or be injured thereby. Any person violating any of the provisions of this section, upon conviction thereof, shall be fined in a sum not exceeding fifty (\$50.00) dollars and costs.

SECTION IO. No person shall sweep or deposit any hay, straw, manure, litter, papers, hand-bills, filth, ashes, tin cans, old clothes, or rubbish of any kind or nature whatsoever on any street, alley, sidewalk, or any public ground or place, or upon any vacant lot in the Town of Arriba, nor burn or set fire to any such material within forty feet of any building within said fire limits, except said fire be within a stoveor other appliance suited to such purpose; and no person shall spit or expectorate or deposit any spit, saliva, tobacco-spit or quid, or other nauseous substance upon any sidewalk or in or upon any floor or hallway of any church building, school building, or county or town building or public hall or any of the walks or stleps leading to any such building. V No person or persons, partnership or corporation being the owner of any vacant lot or lots within the Town of Arriba shall permit any hay, straw, manure, litter, papers, hand-bills, filth, ashes, tin cans, old cloths, or rubbish of any kind or nature whatsoever which may have been deposited upon any vacant lot or lots in the Town of Arriba, to remain thereon, but shall remove the same. Any person violating any of the provisions of this section, upon conviction thereof, shall be fined in a sum not exceeding fifty dollars and costs. Every day such hay, straw, manure, litter, papers, handbills, filth, ashes, tin cans, old cloths, or other rubbish of any kind which remain upon any street, alley, side walk, or other public ground, or place, or upon any vacant lot in the Town of Arriba after notice to remove the same shall have been served by the Town Marshal, Mayor or Town Health Officer upon the person desiting the same in any such place or places or upon the owner of any ant lot, shall constitute a separate offense.

SECTION II. Any person in this town who shall keep chickins, turkeys or other fowls, shall keep the same upon their own premises and shall not permit the same to go upn the premises of others and injure or damage any plants, flowers or other property thereon or commit any nuisance thereon. Any person violating the provisions of this section, upon conviction thereof, shall be fined in a sum not exceeding ten dollars and costs,

SECTION 12. All telephone, telegraph and electric light and power companies, within this town, shall at all times carefully keep and maintain their systems of wires so that the same shall not cross, touch or in any manner affect those of any other system.

From to the injury and damage of the person or property of others, and to this end shall at all times keep their poles, wires and other appliances for the transmission of electricity in good repair and property insulated. If any pole, wire or other appliance shall be broken or for any cause be out of repair the same shall be immedisately repaired, and all broken poles shall be replaced with new ones. Any such company, its agents, employes or persons managing or controlling the same who shall violate any or the provisions of this section upon conviction thereof, shall be fined in a sum not exceeding one hundred dollars and costs.

SECTION 13. Any person or persons owning or having charge of property or vacant lots upon the travled streets of the Town of Arriba, shall keep the snow off the sidewalk space, upon failure to do so within (24) Twenty Four Hours after each snow, storm, the Town of Arriba can have same removed and charge the expense to the property or vacant lots.

SECTION 14. Any person owning or having charge of property or vacant lots within the Town of Arriba, shall keep the weeds cut on the same in the growing season. Failure to do so the Town of Arriba shall have same cut and charge the expense to the property or vacant lots.
