January 6	First day to circulate nomination petition

March 17	Contribution reports required by the Fair Campaign Practices Act must be filed with the Town Clerk today. Mandatory penalty of \$50 per day for each day the report is not filed.
April 3	Contribution reports required by the Fair Campaign Practices Act must be filed with the Town Clerk today. Mandatory penalty of \$50 per day for each day the report is not filed.
April 7	Election Day
May 4	Contribution reports required by the Fair Campaign Practices Act must be filed with the Town Clerk today. Mandatory penalty of \$50 per day for each day the report is not filed.

# NOMINATION PETITION INFORMATION

Election Date: Tuesday, April 7, 2026

**THIS PETITION MAY NOT BE CIRCULATED OR SIGNED BEFORE JANUARY 6, 2026 AT 8:00 A.M. IT MUST BE RETURNED TO THE TOWN CLERK'S OFFICE BY 4:00 P.M. ON JANUARY 26, 2026. THE PETITION CIRCULATOR'S AFFIDAVIT AND THE ACCEPTANCE OF NOMINATION AND QUALIFICATION AFFIDAVIT MUST BE NOTARIZED. A NOTARY PUBLIC IS AVAILABLE AT THE ARRIBA TOWN HALL, THE LIMON TOWN HALL, AT THE LINCOLN COUNTY COURT HOUSE, AND AT THE HIGH PLAINS BANK IN FLAGLER.**

- ✍ Prior to circulating the petition, fill in the candidate information at the top of each sheet.
- ✍ Each candidate must be nominated by a petition signed by at least 10 registered electors residing within the town limits of Arriba from which the candidate is to be elected.
- ✍ **A Registered elector** is a person who on or before the date of the election shall be 18 years of age or older, is a United States citizen, and has been a resident of the State of Colorado for thirty days, has resided in the municipality or municipal election precinct for thirty days and has registered to vote in the Office of the Clerk & Recorder of Lincoln County at least 22 days before the election
- ✍ Registered electors may sign only one petition for each office for which they are eligible to vote. (Example: one person may sign 3 trustee petitions.)
- ✍ Petition signers must sign and print their legal name.
- ✍ Encourage registered electors to sign in ink. Make sure all required information is complete. A signer must use the address where he/she is registered to vote. A post office box will not be accepted.
- ✍ Ditto marks will not be accepted. If a correction is required, the signer should cross out the incorrect information and proceed to the next line.
- ✍ The petition circulator must personally observe every registered elector who signs his/her petition and each signer must state to the circulator that he/she is a registered elector of the Town of Arriba.
- ✍ Do not take a petition apart. [You cannot add sheets to this petition. If you would like to gather more signatures, ask for another petition.] Evidence of disassembly will disqualify the entire petition section.
- ✍ Submit all petitions at the same time.
- ✍ Fair Campaign Practices Act: In accordance with the Colorado Fair Campaign Practices Act (C.R.S. 1-45-101, et,seq.) all candidates for a municipal office must file a candidate affidavit and other reports. Information regarding filing deadlines may be obtained at the Arriba Town Hall. For candidate committee reporting, please consult the Fair Campaign Practices Act Manual.
